HOW DO I KNOW IF MY BUSINESS IS PROFITABLE?

- ➤ Balance Sheet
 - ➤ Provides a list of your Chart of Accounts and shows the dollar amount of each account
 - ➤ Cash/Assets Liabilities = Owner's Equity
- ➤ Income Statement or Profit & Loss Statement (P&L)
 - ➤ Revenues vs Expenses
 - ➤ Budget vs Actual
- ➤ What causes low profitability?
 - ➤ High Overhead Costs, Appropriate Gross Margins, Too Much Inventory On Hand, Accounts Receivables
